PCIM&H is initiated R & D programme for the mutual benefit of stakeholders including graduates, post-graduates and research scholars (Ph.D) of ASU&H system of medicine, Pharmacy, Life Sciences for the training/dissertation work, research and development activities in the area of ASU&H system of medicine.

About the Program

Research and Development Program for ASU&H system of medicine is an initiative to empower our country's youth to make them more employable and more productive. The programme will meet the ambitions of students/young researchers looking for training/do research on ASU&H system of medicine. This programme will provide a platform for the skill development and hands-on experience in the field of standardization, quality control of ASU&H drugs.

Salient Features

The programme will be held at PCIM&H, Kamla Nehru Nagar, Ghaziabad-201002, Uttar Pradesh. The submission of incomplete applications will not be considered. The candidate will have to sign an undertaking regarding not to indulge in unwanted activities, confidentiality etc.

Eligibility

Students pursuing their graduation and post-graduation and Ph. D course from a reputed Universities/Colleges in any of the relevant areas and have secured at least 60% marks in all examinations from High School up to Graduation.

Area of Research work

Chemistry, Pharmacognosy, Microbiology, Pharmacology

Duration of Training

Duration will be minimum 3 months upto 1 year depending upon the recommendation of his/her HOD.

When to Apply

Candidates can submit their applications throughout the year or at the particular/semester period of their academic year.

Criteria for Selection

Eligibility of trainees does not mean that all the candidates applying for the training or dissertation work will be accepted for their research/dissertation work, but it would depend on the availability of expertise in the specific area, availability of infrastructure and lab space in the concerned laboratory.

Fee

The fee @ Rs. 2,500/- for 3 months, Rs. 5,000/- for 6 months and Rs. 10000/- for one year. Training Fee is required to be paid in advance through Bharatkosh portal at the time of joining.

Attendance

During the research work/dissertation program, 80% attendance is must, in case the trainee has less attendance the certificate will not be issued to them.

Hostel Facility

No Hostel facility and candidate have to arrange their own hospitality and transportation.

Instructions for filling the application form:

1. The candidate will have to submit the duly filled and signed application form **(Annexure-1)** along with an official letter from the Head of the Department/Principal.
2. Accepted candidates will be informed through Speed Post/Email. Please provide a valid email address in the application form. PCIM&H shall not be responsible for the failure due to the invalid email IDs provided by the candidate.
3. Course fees can be paid through Bharatkosh (<https://bharatkosh.gov.in/>) portal **(Annexure-2)**
4. While joining, candidates have to bring two passport size photographs and original mark sheets from High School to Graduation.
5. The certificate will be issued only to the successful candidates having 80% attendance in the programme.
