Key mandate of PCIM&H is to develop Pharmacopoeial standards for Ayurveda, Siddha, Unani & Homoeopathy Drugs and to act as Central Drug Laboratory cum Appellate Lab for ASU&H Drugs. Apart from this PCIM&H also imparts Capacity building training programme to the different stakeholders viz Drug regulators/Enforcement Authorities, Govt. Analysts and scientist/technical staff of ASU&H Drug testing laboratories and other scientific institutes.

PCIM&H is convening a training programme for the above stakeholders and other Drug testing laboratories, from 24.06.2024 to 28.06.2024.

The programme will be residential in nature. Training fee will be Rs. 5000/- per participants which will be payable through NTRP (www.bharatkosh.gov.in) before the commencement of the training programme.
